I. Actions taken by the Oklahoma State Department of Health from February 1, 2006 to February 28, 2006 were as follows:

Certificate of Need Applications Approved:

Medford Nursing Home (Servant Living Center-Medford, LLC), #05-160. Contract Person: Scott Pilgrim, 405/285-8177. Acquisition thru lease agreement. Purchase with lease; 84- bed facility; cost: \$300,000; \$10,000 annual lease for 20 years. Approved 2/7/06.
