The Extra Help Assistance Program:

Extra Help Assistance (LIS)

Low Income Subsidy



The average person's savings equals about \$4,900.



If you meet certain income and resource limits, you may qualify for Extra Help. This program helps pay for your Medicare drug coverage, such as plan premiums, deductibles, and costs when you fill your prescriptions, called copays or coinsurance.

Eligibility

Income:

- If you are single up to \$1,719
- If you are married up to \$2,309

Assets: (not including your home, vehicles, or burial allowance)

- If you are single up to \$15,510
- If you are married up to \$30,950

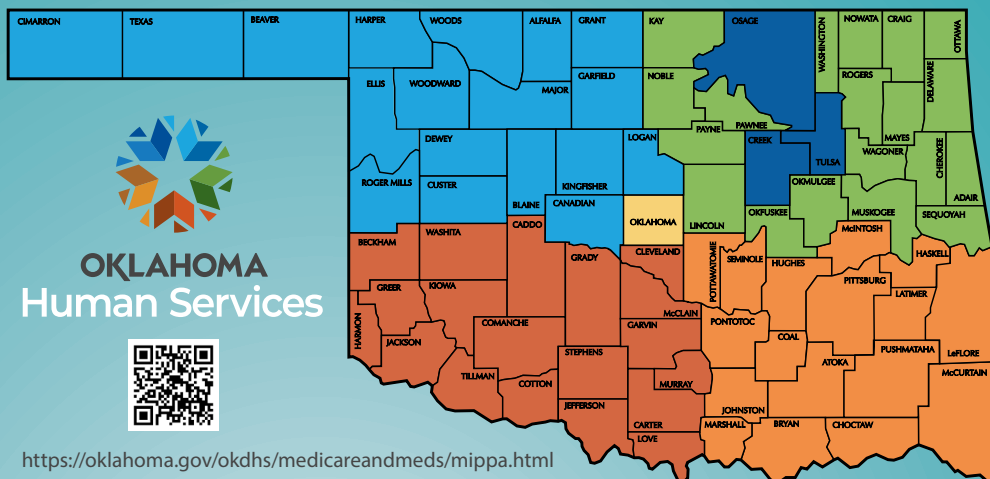

Medicare Savings Programs

Medicare Savings Programs (MSP)



Could increase your Social Security check.



Helps pay for hospital and doctor visits



MEDICARE SAVINGS PROGRAMS (MSP)

You can get help from your state paying your Medicare Part B premiums if you have limited income and resources. Save \$170.10 a month.

In some cases, Medicare Savings Programs (MSP) may also pay Medicare Part A (Hospital Insurance) and Medicare Part B (Medical Insurance) deductibles, coinsurance, and co-payments if you meet certain conditions.

You may qualify for the Medicare Savings Programs (MSP) if you have or you are eligible for Medicare Part A and you meet the income and resource limits below.

Income:

- If you are single up to \$1,549.
- If you are married up to \$2,080

Resources:

- If you are single up to \$8,400
- If you are married up to \$12,600
